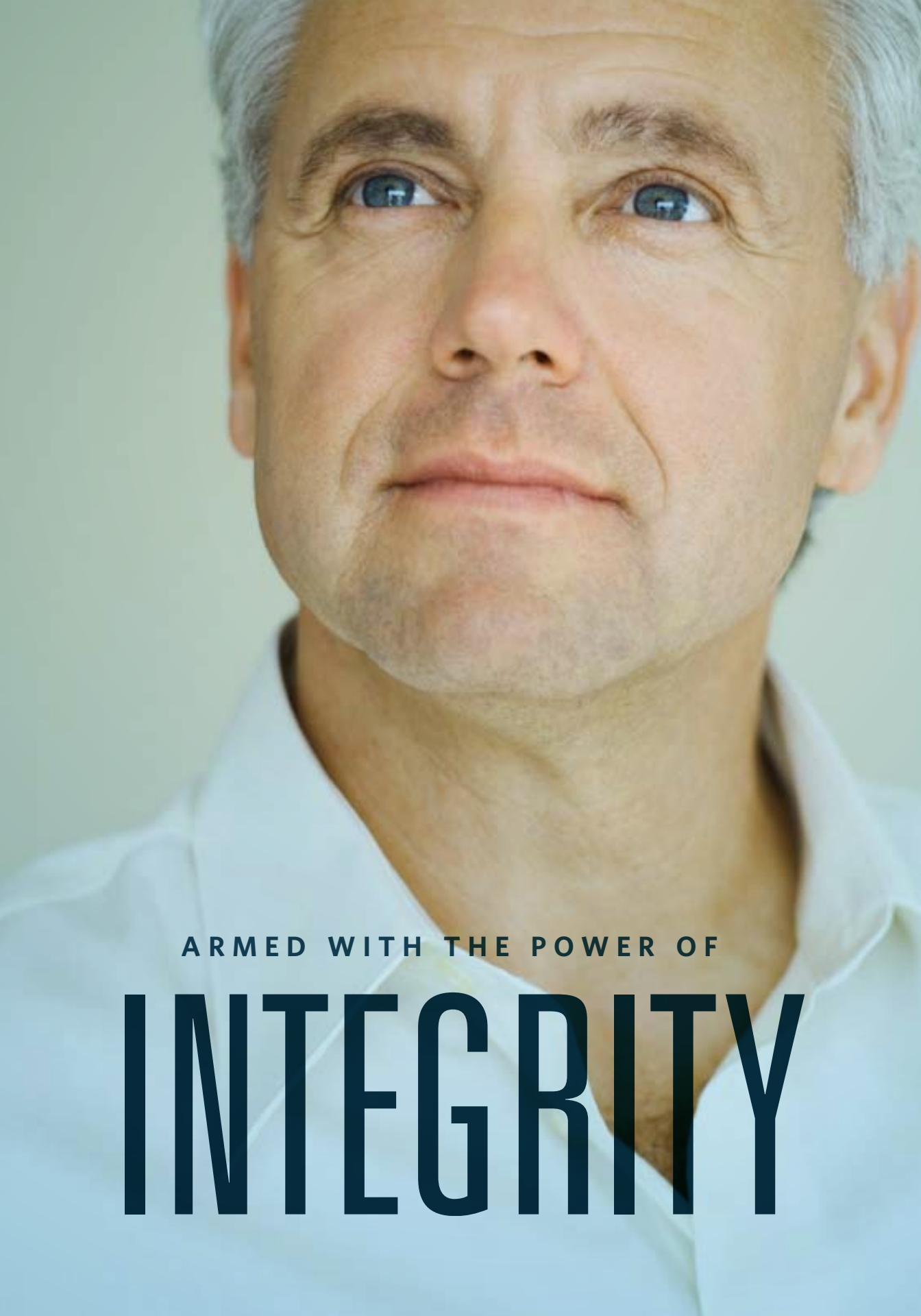

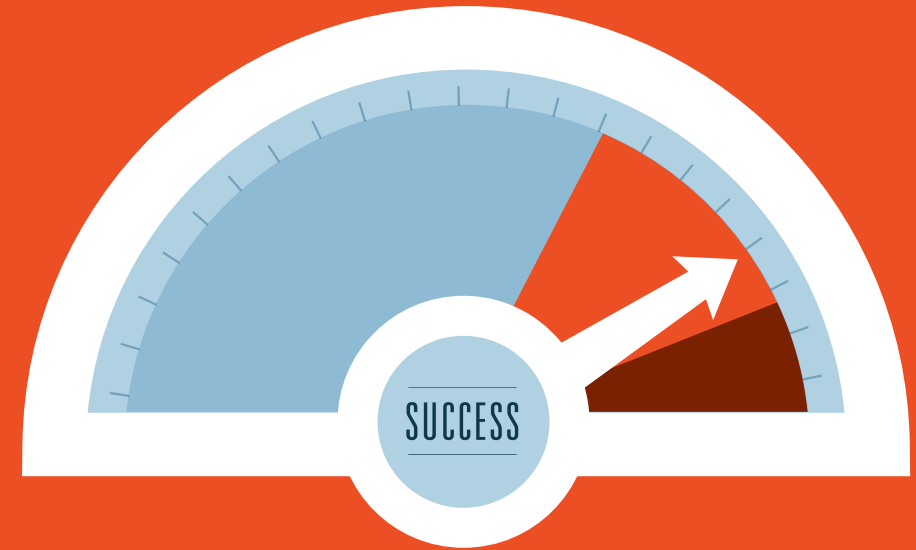
that led to the arrest, and to make sure who our client really is doesn't get lost amidst the stories floating around about Cause Number DIDC092367198.

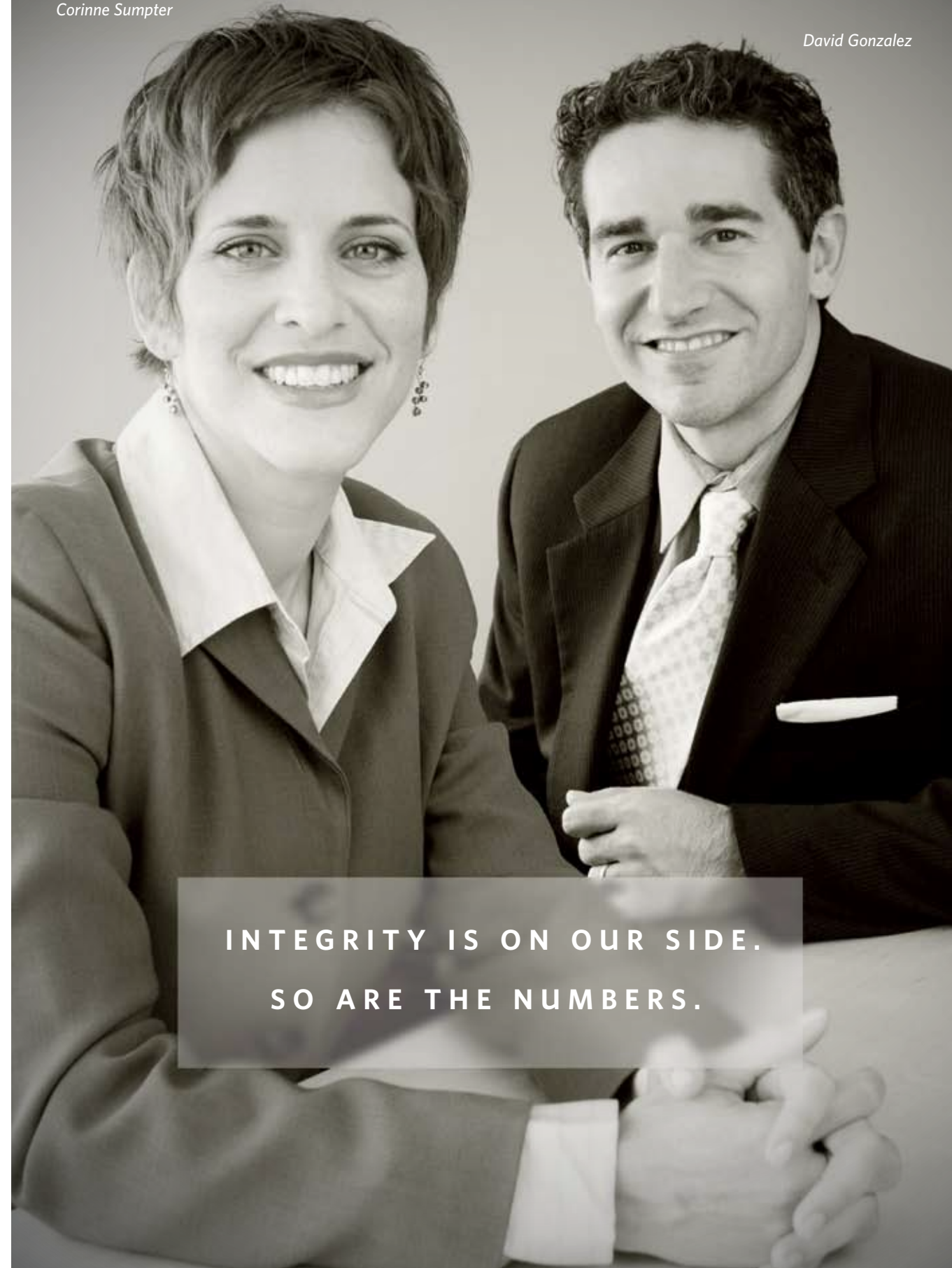
